TRAINING 2

ETIOLOGY OF PSYCHIATRY

In this section of training, we want to explore the main streams and sub streams of psychiatry. We will begin with conventional psychiatry. This is the form of psychiatry most people know and the form which is generally accepted by the majority of the population. Then, we will get into top secret psychiatry.

CONVENTIONAL PSYCHIATRY

Conventional psychiatry is the most common form. In order for conventional psychiatry to appear to have validity, certain conditions must be met. Conventional psychiatry will only appear to have validity among a group of people in a specific state of consciousness. There are three main requirements. These are: (1) Belief in Scientific Atheism, (2) Total absence of any type of mystic experience such as an out of body experience and (3) a philosophic world view that is in conformance with Darwin's evolutionary theory coupled with a materialistic philosophy which asserts that nothing exists other than observable physical reality.

If all of these conditions are met, conventional psychiatry makes perfect sense. Since most of the people in the world live in this state of consciousness, conventional psychiatry has gained acceptance.

Having accepted these conditions as absolute fact, it then becomes logical to call people crazy for beliefs such as the belief they have lived before, the belief that the universe was created by an intelligence and was not a random accident, the belief that they have a Soul, the belief in GOD and the belief that other dimensions exists which are invisible to most people but can be accessed by some. In conventional psychiatry, having any of these ideas is grounds for use of the schizophrenic label.

ECONOMIC THEORY

In economic theory are three main categories of profitable events for those interested in huge economic potentials. The highest category is the exploitation of a *civilization in decline* such as the fall of the Roman Empire or the predicted future fall of the United States. The next most profitable event is *war*. The last and least profitable event is a *civilization in creation* because you must "sacrifice" some of your capital to pay people to create the new civilization.

Well, what has all this to do with psychiatry? Even though we are dealing with an event on a much smaller scale, the basic principle still applies. The highest profit for a psychiatrist is to find someone who is financially successful, convince them that they are "sick", and then gradually steal everything they own in fees and services until they are totally wrecked and eventually die from major organ failure because of the slow poisons [drugs] they conned them into accepting.

THE BELIEF SYSTEM THAT ASSERTS HARM IS BENEFICIAL

When witches were being tortured into confessions and burned at the stake, the most obvious interpretation of these events would be that this was a form of punishment. However, this is incorrect and not at all how the process was viewed during those times. Actually, people believed that the witch was being "saved". They felt that burning a witch was the only way to "save the witches soul" and, therefore, it was a joyous occasion to watch a witch burn.

If this seems totally whacky to you, compare it to conventional psychiatry which burns out people's brains with electric shocks, tortures them with poisons based upon pesticides which are now called drugs, and occasionally performs frankenstein style brain operations. Clearly, these poor people suffer just like the burning witch. However, devotees of conventional psychiatry do not feel they are causing harm but rather feel they are "saving" or curing the person of these horrible beliefs they have which conflict with the official philosophy of conventional psychiatry. They can't bear the thought that others disagree with their would view and feel they must convert them over to their way of thinking.

JUDGE DREDD

"Judge Dredd" is a classic fiction movie set in a future time where the police are called "judges" because they can accuse someone of a crime, arrest them and sentence them all on their own authority. Pretty scary.

Unfortunately, in the case of psychiatrists, the future is now because that is the power the law gives them. A psychiatrist can accuse someone of having an illegal personality, convict the person on the spot and order the person taken away for indefinite detention and forced drugging at a concentration camp. That's all it takes to put you away for the rest of your life. So, if you saw the movie "Judge Dredd" and were frightened, you can be truly scared now because this is not fiction from the future. This is present day reality.

JUDGMENTS

Although judges empower psychiatrists to force their will on people who want nothing to do with them,

these judicial orders do not specify exactly what will be done. If judges actually ordered "treatments" using specific language it should, at least, raise some eyebrows. Let's look at some examples of what such specific orders would look like:

JUDGE: "You have been found guilty by virtue of expert opinion of having a personality in violation of DSM section _____. I therefore order that your life be shortened by 25 years."

JUDGE: "The expert has informed me that you are a useless eater and of no value to our society. I therefore order that you be forced to take drugs that will render you sterile so that you cannot pollute the gene pool with any more defective people. If you refuse the drugs, I order that you be taken to a concentration camp where the drugs will be forced upon you."

JUDGE: "The expert witness [psychiatrist] has stated that you pose a danger to our social order because of your beliefs. I therefore order you to be brain damaged to the intelligence level of a moron so that you cannot contaminate our orderly society with your disruptive ideas."

These are the things psychiatrists actually do. However, they are not specified as such. The order will only usually say the psychiatrist may give treatment without consent. No one ever questions or specifies exactly what "treatment" is.

INTERNATIONAL LAWS AND CONVENTIONS

In daily practice, psychiatrists routinely violate international laws and conventions. Mainly they violate conventions on torture and genocide.

Psychiatrists routinely force drugs upon people which make them incapable of reproducing. Forced eugenics is considered genocide and is classified as a crime against humanity. If these activities were being carried out by some entity other than psychiatrists, there would be calls for prosecution before the world court. However, no one seems interested in condemning psychiatrists when they do these things.

How "patients" are handled in the state concentration camps could easily be considered torture under international conventions. Tortures such as "stringing up" where patients are handcuffed to high window bars and left dangling for days and using taser guns to threaten and attack patients to crush them into submission should qualify as torture.

PROVIDER - CLIENT - PATIENT/PEST

Recall that the original group of major tranquilizer drugs were made by modifying phenothiazine, a chemical already in use as a pesticide. Pesticides, of course, are designed to kill "pests". People given these pesticide based drugs die about 25 years sooner than the average person and generally shake and

tremble just like a pesticide sprayed bug would shake and tremble before it dies.

So, in playing with nomenclature, when you call the bug man to kill, say, roaches, who is the provider, client and patient. Well, the bug man is the provider. You are the client. The roach, then is the "patient" [pest] to be killed by the provider. In the mental health game, what is the correct use for these labels? Well, the psychiatrist is obviously the provider. Who is the client? It is not the patient. The patient is chained to a bed in a government concentration camp and is not consulted about anything. The true client is whoever desires the patient [pest] killed and has asked the psychiatrist to "do the deed". Satisfaction of the client is the objective - not the welfare of the patient. No one cares what happens to the patient as long as the client is satisfied. Similarly, no one cares about the welfare of the roaches the bug man will kill - you just want them gone so you won't have to think about them any more.

THE ATHEIST ISSUE

In most cases, a person's religious preference is not an issue. If you have someone painting your house or working on your car, who cares what they believe. However, if you have someone working on you, their belief system will influence how you are treated. The US "founding fathers" wrote that people were endowed by their Creator with inalienable rights which included the right to life and liberty. Today, it is considered politically incorrect to talk about "creationism". You must accept the theory of evolution. If you are a disciple of Charles Darwin and therefore do not believe in a creator, what, if anything, are the rights of others. Since you believe people are random chance accidents, how do you determine what is the correct approach to dealing with them. Are people with money important and those without worthless trash? What guidelines should you use. Among atheists, eugenics is popular. This philosophy asserts that you should breed "the best" people and kill "defective" people just as you would do with livestock.

All of this becomes deadly serious if you happen to be a Spiritual person and you are captured by an atheist psychiatrist who gets his authority from an atheist judge. Your fate is sealed if you should find yourself represented by an atheist attorney. The odds actually favor this scenario. None of these people are capable of understanding you. They have simply not reached that level of development. So, if the psychiatrist accuses you of hearing voices no one else hears or seeing things that are invisible to others, the judge is going to authorize whatever the doctor wants and your attorney is going to just stand by and let you be brain damaged and, eventually, killed because he thinks all of this is actually helping you.

TOP SECRET PSYCHIATRY

Conventional psychiatry, of course, has no absolute validity. It is simply a belief system that offers comfort to people who are Spiritually immature. Lately, government scientists, seeking military superiority, have been researching ways to help government operatives develop psychic powers which can be used for spy work and psychic assassinations [black magic]. Clearly, a weapons system is of little practical use if everyone else has the same system. So, the object is to develop new systems which

others do not have and keep them secret so others do not get them or even know they exist.

The government's initial breakthrough was remote viewing. This relatively simple technique, which has been used by so called "primitive" people ever since people have existed, is a variety of bilocation technique which allows a person to "view" a distant scene while being physically conscious and relaying his remote observations to his controller. Remote viewing requires access to an Astral dimension and the target can be in the present, past or future.

Consequently, psychiatrists who train and work with remote viewers and other psychic operatives know that conventional psychiatry is totally false. There are other dimensions. Entities live there. You can communicate with invisible conscious creatures. So, all the people being tortured by conventional psychiatrists for being schizophrenic are just people who are naturally psychic and had the misfortune to come under the influence of conventional psychiatry.

PATHS AND CHOICES

Most people live out their lives in total ignorance. However, once a person realizes that other realities exist, they must choose to follow either the Right Hand Path or the path of good or the Left Hand Path or the path of evil. Psychiatrists working for the US Government have chosen the path of evil and devote their time to psychic development for the purpose of harming others. Consequently, the United States is known in other countries as the "Great Satan". However, it is also possible for a psychiatrist to choose the path of good and try to legitimately help others. We know little about this group of psychiatrists. However, logically, some should exist.

DOUBLETHINK

A government psychiatrist quickly learns the art of "doublethink", a term coined by George Orwell in his classic novel "1984". If he works with someone "inside" the government, he admits the existence of psychic powers and helps the person to develop them. However, if he should meet someone "outside" of the government who shows signs of psychic development, it would be his duty to label them schizophrenic and have them locked away.

THE NEEDS OF MATERIALISM

In the past, before technology existed, psychic development was more common. People needed to create things as opposed to consume things from an external provider. If you wanted music, you had to invent a drum, flute and other instruments and then learn how to use them. More recently, it would have been common to find a piano in a home instead of a home entertainment system which depended upon an external provider. In these past times, people looked inward. They learned to understand

themselves. They lived in harmony with nature.

In today's world, people exist as slaves of the elite. Independent thought is discouraged. Knowledge is programmed into people from coordinated external sources outside of their control. Clearly, you can't maintain such a system if your slaves should realize that they have the inner ability to access knowledge which you cannot control - if they begin to "listen to a different drummer". The ruling oligarchy was terrified in the 1960's when LSD became popular because it initiated people into alternate realities. All those captured were labeled schizophrenic and told they must take drugs forever to prevent a "relapse". Heaven forbid they might realize the reality they had been carefully conditioned to accept was an illusion.

Consequently, government sponsored psychic research is given one of the highest security clearance levels possible. Truth is considered a threat to the nation and the nation intends to use all methods available to make sure that the "sheeple" stay fast asleep.
