INTRODUCTION

The **CHURCH OF SCHIZOPHRENIA** is a religious order based upon the sacred belief that all of the attributes which are called schizophrenic by psychiatrists are, in fact, psychic and/or Spiritual qualities at some stage of development and are therefore attributes that are protected by the First Amendment rights of the US Constitution. The forced interference by psychiatrists - who are agents of the state because their authority comes from the US legal system - into the lives of people because they are called schizophrenic is both unconstitutional and a violation of applicable civil rights legislation.

The purpose of the Church is to stop the unconstitutional abuse of its members, to protect its members from future abuse and to help its members recover from past psychiatric abuse so that they may develop and achieve their true Spiritual potential.

Psychiatrists apparently love each other, however, beyond their closed world, they are generally viewed as evil people. Essentially all major motion pictures cast the psychiatrist in the role of a villain. Some examples are:

- 1. BEDLAM An old black and white movie in which the patients eventually revolt and kill the psychiatrist by burying him alive behind a new brick wall.
- 2. A CLOCKWORK ORANGE A movie showing the disastrous consequences of behavior modification and aversion therapy.
- 3. ONE FLEW OVER THE COOCOO'S NEST A classic motion picture where the hero, having survived shock treatments, is then destroyed by brain surgery.
- 4. BATMAN BEGINS A movie where the central villain is the psychiatrist who drives normal people mad using his special drug.
- 5. FRANCES A documentary movie about actress Frances Farmer who was denounced by her mother to psychiatrists who destroyed her with psycho surgery she lived but died alone and miserable.

LABELS AND DEFINITIONS

There is a cute little song from Gilbert & Sullivan's "Mikado" sung by the "Lord High Executioner" which begins:

As some day it may happen that a victim must be found, I've got a little list — I've got a little list

Of society offenders who might well be underground, And who never would be missed — who never would be missed!

The song goes on to detail those persons who "would not be missed". If you want to read all the lyrics see http://math.boisestate.edu/gas/mikado/webopera/mk105a.html.

The psychiatric label system is basically a wish list of those persons who an authoritarian society would be "better off without". The older lists, such as the 1942 APA list, are much more specific than the present DSM-IV list as to who should be eliminated. For example, on page 140 of the 1942 list [http://louisianastatehospitals.com/Lewis%20Book.pdf], category 001-x30 "paranoia" specifies "certain types of litigious persons, reformers and prophets". Clearly, any self respecting dictator would not want litigious persons [people who insist on their legal rights], reformers [who would seek changes in the status quo] or prophets [who might stir up a protest or two]. They would "never be missed".

There are hundreds of mental illness labels in both the old and new lists, however, if you want to hold people against their will and force drugs on them, you can really only use one of two general labels. These are 1. Bipolar Disorder [previously called manic-depressive] and 2. Schizophrenia. Courts have ruled that the other labels are too vague. The difference is that, although people in the Bipolar Disorder category have periods of high energy, they do not have an interdimensional experience. The Schizophrenic class has interdimensional experiences. Many psychics feel that the high energy or manic phase of bipolar disorder should be considered a religious experience and that the surge of energy should be considered a "gift". However, the people in this class generally do not realize this. The experiences of the people in the schizophrenic class, such as Astral projection [called "disassociation" by psychiatrists], communications with spirit guides [called auditory hallucinations by psychiatrists] and various Astral vision experiences [called visual hallucinations by psychiatrists] are clearly within the spectrum of religious experiences which are protected by the US Constitution under "freedom of religion".

Let's take a look at the specific labels from the old [1942] and new [DSM-IV] lists for the schizophrenic group.

The 1942 lists gives five subgroups:

- 1. Simple schizophrenic defined as being apathetic
- 2. Hebephrenic schizophrenic defined as laughing inappropriately [like Peter in the cartoon show "Family Guy"]
- 3. Catatonic schizophrenic defined as states of physical paralysis
- 4. Paranoid schizophrenic this label is a favorite to use for political prisoners because of its weird definition basically, the definition is that this is a very sick person but the person is pretending not to be sick so that everyone thinks he is normal. However, a psychiatrist, because of his "special powers" can see that the person is sick even though no one else can. So, this definition allows the state to pick up anyone off the street it does not like [got a little list] and call them a paranoid schizophrenic and lock

them away. By example, when Jim Garrison began investigating the Kennedy assassination as a conspiracy, he was immediately called a paranoid schizophrenic.

5. Other

In DSM-IV, the list has been changed. "Simple", "Hebephrenic" and "Other" have been removed and "Disorganized", "Undifferentiated" and "Residual" have been added.

"Paranoid" and "Catatonic" are the only sub classes that survived from the 1942 list to the current DSM-IV list.

The DSM-IV definitions are more vague than the 1942 definitions and appear to have been written with a view toward political correctness. The 1942 definition for paranoid schizophrenic describes the person as having "homosexual tendencies". This was ok in 1942 when gay people were classified as "sexual psychopaths" but it is politically incorrect today because gay people became politically active, protested, and had themselves "taken off the list" so they are now all magically "perfectly normal". Other people "on the list" have also protested, however it is unlikely that psychiatry would ever be willing to give up its two "cash cows", schizophrenia and bipolar disorder, because doing that would effectively put psychiatrists out of business.

The DSM-IV describes schizophrenia in terms of "positive" and "negative" symptoms.

The "negative" symptoms are apathy, blunted effect, depression and social withdrawal. These "symptoms" just happen to be what the drugs that are usually forced on schizophrenic people cause. In fact, they cause such a desperate state of depression that many commit suicide.

Now, lets look at the "positive" symptoms. Here are some excerpts from the "official descriptions":

- 1. "Hallucinations are thought to be a result of over-sharpening of the senses". Any program of Spiritual meditation causes "over-sharpening" of the senses. It is a desired effect of Spiritual evolution and is a protected activity under the freedom of religion guarantees of the US Constitution. To interfere is a rights violation.
- 2. "Delusions are strange and steadfast beliefs". Any religious experience is going to sound strange to a scientific atheist which is what psychiatrists are.
- 3. "Thought disorder refers to problems in the way that a person with schizophrenia processes and organizes thoughts". Great so now we have the Thought Police right out of Orwell's "1984".
- 4. "Altered sense of self is a term describing a blurring of the ill person's feeling of who he or she is. It may be a sensation of being bodiless, or non-existent as a person. The ill individual may not be able to tell where his or her body stops and the rest of the world begins. It may be as if the body is separated from the person." This statement is proof positive that psychiatrists are calling Spiritual evolution "schizophrenia" and that they are actively attacking spiritually developing people and damaging them

with their brain destroying drugs. Since psychiatrists are atheists, they apparently do not realize that what they have described is *exactly* what is expected of any person who embarks upon a course of Spiritual development. The human body is an illusion and so is this place. These truths are taught by all Spiritual masters, mystics and gurus wherever they may be found anywhere in this world.

THE HISTORY OF PSYCHIATRY

Although people have been constructed the same way for thousands of years, the "psychiatric" way of looking at people is relatively new. Early models argued that mental illness was the result of "sinful behavior" and, gradually, the models changed and continue to change from day to day and year to year. Homosexuals were "sexual psychopaths" in the 1950's but, today, they are completely normal and it is "politically incorrect" to say bad things about them. There have even been proposals that young gay people should have their own schools so that they could "be with their kind" and be "protected from discrimination". The first history reference we will look at is a German reference which traces psychiatry from its origins based upon some concept of sin thru the Nazi period where mental patients were simply gassed to death and takes one up to the present psychiatric philosophy in Germany: http://psy.uniklinikum-leipzig.de/eng/geschi-e.htm

The second reference is more critical but it is a very important reference because it details how ECT or "shock treatments" originated. ECT originated by adapting an electrical device used to prepare cattle for slaughter by shocking them into a state of confusion before they were killed. Some "doctor" saw this - decided to try it on people - and ECT was born. Incredible! http://www.sntp.net/evolution.htm

ANALYZING THE ANALYST

If we use the guidelines from the DSM-IV and the ICD-10 [the international equivalent] to analysize the personality of the typical psychiatrist, we find that he is clearly a psychopath or a sociopath [the terms are interchangeable] based upon the defining markers:

- 1. Callous unconcern for the feelings of others
- 2. Incapacity to maintain enduring relationships [temporary wife, etc.]
- 3. Reckless disregard for the safety of others [e.g. forcing IV Haloperidol on people when the FDA web site has specifically warned it is not approved for IV use and may kill].
- 4. Deceitfulness repeated lying [like telling patients or responsible parties that things like drugs and ECT are "harmless"]
- 5. Incapacity to experience guilt [e.g. designing torture methods for the government and doing weird experiments which kill or permanently injure the subjects without so much as "batting an eye"] Unfortunately, nothing can be done to "protect society" from this psychopath because this psychopath is the one who "makes up the rules" for *others* to follow and is therefore "above the law".

"SPN" CODES

For those old enough to remember the Vietnam war, it was not enough for the government to ruin the lives of young people by drafting them and sending them to Vietnam: the government wanted to make sure that their lives were permanently ruined assuming that they managed to return from the war in one piece. To accomplish this, they devised a secret code, known as the "SPN Code" which was printed on military discharge papers. To get a job, you had to show these papers. All companies who were associated with the government were given the secret list of codes. The men who were discharged had no clue about them at all. The codes correlate with a secret list of mostly brief slanderous phrases designed to ruin the remainder of the x-soldier's life. They look like the things psychiatrists like to write although, since the whole program was secret, there is no way to know for sure who made "the list". Some examples are: Code# SPN-263 = Bedwetter; Code# SPN-46C = Apathy/Obesity [what's the relationship between the two - who knows]; Code# SPN-464 = Schizoid Personality; The Codes from 251-257 are all for Homosexual which was a mental illness at that time. Homosexuals are classed as "Class I Homosexual" or "Class II Homosexual". Apparently, you could be court marshaled for this. To see the complete list of codes use this link: http://www.cvva.ca/SPNCodes-Definitions.pdf You would expect the US to show some respect for those who fight for the country but, as you can see, they are treated as trash and this continues today for those serving in Iraq and Afghanistan.

SEX

SEX makes babies. However, the sex force or libido does many other things as well. You may or may not be aware of these additional qualities of libido.

The first thing you need to know is that authoritarian minded people, throughout the ages, have known that, if you can somehow take control of a person's sex force or libido, you can control that person. Consequently, we have a history filled with assorted experts, dictators and preachers who have devised ways to control your sex life so that they can take control of your life in general and make you their slave.

The people who sit around inventing new ways to screw up your sex life never practice what they preach. These people love sex and have lots of sex themselves even though they may pretend to be celibate or promote the illusion that they are somehow of superior moral character.

The notion that highly spiritual people somehow "outgrow" the desire for sex has persisted for generations. However, this level of spiritual development, if it exists at all, must be very high as reports continue to surface from scholars that even Jesus Christ had a mate and fathered children.

Forcing yourself to give up the desire for sex will not make you "more spiritual". It will just make you sexually frustrated. It will also make you return to this world in a new body again and again until the desire is satisfied. This is also true for any other desire which can only be satisfied in material reality. You must deal with these desires while you have a physical body. You cannot just suppress them or pretend that they do not exist and expect to have any reasonable hope for Spiritual liberation.

In the religious arena, for example, the "celibate" Catholic priest actually has a great sex life. He has many choices. He can have gay sex with another priest. He can have sex with a nun. He can have sex with some church member when he goes to their home to "spiritually comfort" them. And, to spice things up a bit, he can always rape a child. The church has had to deal with pregnant nuns for years. In the beginning, the nuns simply had their baby and then looked around for some convenient place to put it like under the floor, between the walls or in the attic. We know this because, when old buildings used by nuns are demolished, tiny skeletons mysteriously turn up. Later, in the period of the 1950's, the church devised a more humane method. By then, the Catholic church had a network of hospitals and also a network of orphanages. So, the nuns would give girth in a secret section of a Catholic hospital and then the baby would be sent to a Catholic orphanage as an "abandoned child". Today, reportedly, the church just gives the nuns birth control pills. In the political arena we have much the same story. When Bill Clinton became president, he signed legislation prohibiting sex sites on the internet. Today we all know that, at the same time he was trying to ban sex from the internet, he was in the back room getting blow jobs from his mistress, Monica the white house intern. Washington D.C. is reported to have more whore houses than fast food restaurants. Also, the laws in Washington D.C. have been "adjusted" to shield the members of congress who like to screw around with kids. The age of consent in Washington D.C. is set at sixteen. Also, it just so happens, you must be at least sixteen to be a congressional page. So, it is perfectly legal for Senators and Congressmen to screw around with the congressional pages. The only trouble they can get into is bad publicity should the press find out, which does happen occasionally. However, you should realize that getting to be a congressional page is quite an honor. The young kids there most likely have political ambitions which can be greatly helped should they become especially friendly with important people. So, why should they risk losing all this by going public about the affairs they have with influential people who could benefit them in the future. Monica never meant for her exploits to become public. The silly girl believed Clinton was going to divorce Hillary and marry her.

The United States was created by a secret male only club known as the "Masons". They designed the physical layout of Washington D.C. to be exactly the same as one of their "temples". The masons worshipped the "creative force" which they symbolized by an erect male penis. Wherever you find obelisques, anywhere in the world, they are all phallic symbols. The Washington monument in Washington D.C. is a good example. The Masons felt that "ordinary" people, i.e., people who were not members of their group, should be allowed certain rights but that ultimate power should be held by the elite. Therefore, "ordinary" people are not allowed to directly elect the President of the United States. Instead, a select group of people, called "electors", elect the President. It was assumed that these "select" people would naturally be members of the secret clubs and, therefore, ultimate power would always be in the hands of the "chosen" elite. This is essentially how things remain today. All of this is public knowledge. However, it is not "common knowledge" and so many people do not know these things which, originally, were closely held cult secrets.

While we are on the subject of US society, did you realize that for every homicide in America there are seven suicides. You live in a society where life has become so miserable for the average person that they would rather kill themselves than continue to live here.

Various methods have been used over the years to sexually frustrate the general population. These methods fall into the two main categories of physical methods and psychological methods or "psy ops".

The physical methods include such things as circumcision for men and amputating the clitoris for women. Also, there were "chastity devises" invented for both women and young boys.

The "psy ops" were generally propaganda programs to convince people that sex was dirty, that it was evil to enjoy sex, that sex was only for making babies and that only specified positions could be used to have sex. Missionaries advocated the "missionary position" which just happens to be the least stimulating of any position one could use to have sex. Some religions did not even want you to see who you were having sex with. These practices, which continue today in some groups, required you to have sex thru a hole in a sheet which completely covered the other person. Sometimes the psy ops were enforced by law and you could be put to death if caught violating them. In recent times, people have become more sexually educated. It is no longer possible to scare kids by telling them ridiculous things like "masturbation will make you go blind". Therefore, the government now has a new method to scare people away from sex: kill them with AIDS. Here is the link to William Cooper's testimony on how the US Government paid scientists to create AIDS so as to kill off unwanted people: http://www.totse.com/en/conspiracy/the_aids_conspiracy/coopaids.html Clearly, from Mr. Cooper's report, anyone who dies from AIDS has been deliberately murdered by the US Government. For years Cooper, who had a top secret or "Q" security clearance when he worked for the US Government, hosted a short wave radio show where he exposed government secrets including AIDS. However, when he started to tell the truth about the recent wars in Afghanistan and Iraq, the government had enough of his meddling and so they went to his home one night and killed him.

The History Channel periodically runs its series on the "History of Sex". Try to see it if you can. Also, you can probably buy the DVD from the History Channel if you have extra cash lying around.

The effect of these efforts, over hundreds and perhaps thousands of years, has been to cause the Spiritual degeneration of the general population of the earth. To understand this, you need to know a little bit about how Souls come into this world. Having a child is an interdimensional experience. Although a woman creates or grows a new physical form, the soul which gives the new body life comes from the Astral world where it has been waiting for a chance to have another physical lifetime. The soul enters the new body thru the soft spot at the top of the head. To make it simple, think of it as "jumping down into a hole". You can have a soft landing or a hard landing. The force of the natural joy and love between two people creates a bridge for the new soul and results in a "soft landing" which greatly increases the chance that the new child will remember its past lives and develop psychic and spiritual

abilities. However, when people have dispassionate sex as advocated by the churches, the new soul has a "hard landing" and is likely to be "spiritually challenged". The sex advocated by churches and other authoritarian sources is no different from being raped or going to a sperm bank to "buy a kid". The "love force" is absent in such cases. The people who advocate these dispassionate methods know exactly what they are doing. They want to make sure that they remain the bosses and that the rest of the people are handicapped so that they will submit to their will.

The libido has uses other than making babies. These uses have been known since people have existed on the earth. We are going to touch on some of the main uses, sex magic, the Kundalini and Tantric yoga. It is important that you know about these things. Fortunately, due to the internet, there is a great deal of information available to the general public today which was once the closely guarded secrets of private groups.

Sex magic involves controlling and directing the sex energy generated between two lovers to cause some specific event. The force can be used for good or evil. This is the link to the Wikipedia definition of sex magic: http://en.wikipedia.org/wiki/Sex_magic. You will find many references on this subject if you simply do an internet search for "sex magic".

The Kundalini is going to require a bit more to explain. The Kundalini is a force, dormant in most people, that can be developed to give a person supernatural powers. The term "supernatural" is really misleading, since everyone could have these powers if they knew how to develop them. Normally, one studies under a Kundalini master to develop these powers. The Kundalini is a powerful force and it is always recommended that one have a competent master before attempting to play with it. However, it sometimes happens that some sequence of events leads to activation of the Kundalini in a person who has no knowledge that there is even such a thing as the Kundalini. Unless such a person happens to have the good fortune to somehow be guided to a legitimate Kundalini master, they are pretty much guaranteed to be called insane and they would most likely even believe it themselves. You cannot see the Kundalini. It is part of the subtle system of bodies that we all have but which are not in the physical dimension. They are mostly in the Astral dimension or plane. This is the place you came from before you were born and the place that you will likely return to when you die. Here is a good link to use to begin to familiarize yourself with these things: http://www.crystalinks.com/chakras.html It is important for you to know that you have an Astral body and to basically understand the chakra system because those who may wish to harm you and who do know about these things can cause damage to your "invisible parts" which will then adversely effect your "visible" physical body.

Tantric yoga can be used to create a state of consciousness where you can leave your body thru the top of the head as a pure Soul. This is the same way you entered your body when this physical incarnation began. Tantric yoga is *very* sexy and involves lots of sex with multiple partners. As usual, you should practice this under the guidance of a master of this form of yoga. The realization that you are a pure Soul and that you can exist without your physical body represents final liberation from this reality which you now know is really an illusion. No force can harm you beyond this point. You have achieved liberation or "Nirvana". This is the goal of all legitimate mystic schools. However, it is interesting to

note that most methods call for controlling or suppressing the sex force whereas Tantra calls for using this force to the max. Clearly, this is much more fun than a life of rigid austerities and, since it leads to the same result, there appears to be no valid reason not to use the "fun" method as opposed to the "miserable, deprived life" methods.

The modern "inquisition"

You may have thought that the "inquisition" - the initiative by the church to question people to see if they had the "right" thoughts and behavior - was ancient history. Giving the wrong answer to the "inquisitor" could easily get you killed. Today, the old inquisition has evolved into the mandatory "psychiatric screening" which is usually done on school children (probably because most adults would not put up with it). Anyway, it works the same way as the old inquisition: give the wrong answer and you're screwed. You won't be killed but you will be force drugged, probably for the rest of your life.

Hitler, "mercy" killings, forced sterilizations, Nazi philosophy and eugenics

Hitler believed killing off certain people would benefit society. In some cases, he was willing to accept forced sterilization in lieu of killing. Because of his beliefs which he translated in to actions which shocked the world, international laws and treaties were enacted to make sure that this kind of thing could never happen again. Hitler is dead but, unfortunately, his ideas are not. The "eugenics" movement of today advocates Hitler's belief that the world would be better if "certain people" were not in it. Psychiatrists actively practice the Nazi philosophy. Once they decide that someone is mentally ill, they do their best to take that person out of existence. If they could, they would burn them in furnaces like Hitler did. But, they can't. They also can't use forced surgery to sterilize them. It is illegal. However they can sterilize them by forcing drugs on them which make them sterile. And, they can reduce their natural lifetime by about one third due to the long term effects of the drugs they do force on them. Unfortunately, when the international agreements prohibiting forced sterilization of people were written, the chemical methods used by psychiatrists had not been invented. So, the international laws only focused on surgical sterilization of the "unwanted". The international laws need to be updated to cover all of the new techniques which clearly violate the spirit of these laws if not the technical "letter of the laws".

Additionally, psychiatrists who have people locked up in institutions can easily kill them deliberately with essentially no chance of ever being brought to justice. One government web site (unintentionally, hopefully) even gives specific instructions on how to quickly kill someone using IV Haldol: http://www.fda.gov/CDER/Drug/InfoSheets/HCP/haloperidol.htm

Once a state mental hospital is established, it quickly acquires the qualities of a cult. These hospitals are often located in rural areas and most employees come from the closest small town. They all know each other and protect one another. The "patients", on the other hand, are just "things" that arrive in chains from time to time and need to be "controlled". Nurses are not going to report doctors who violate the law because, if they do, they will be fired and blacklisted so that they can never work as a nurse again.

A doctor is not going to turn in another doctor because he is just as guilty of abuse himself. The classic "prison experiment" [http://www.prisonexp.org/] done at Stanford University some years ago suggests that whenever there is a situation where some people are put in absolute control of other people, it is "normal" to expect serious abuses to routinely occur. The experiment, which is required study for all psych students, involved paying normal volunteers to play the part of either a prisoner or a prison guard. The experiment had to be stopped early because of the abuses that occurred and some of the "prisoners" suffered legitimate and serious psychological damage. It would be unreasonable to expect that inmates locked in state hospitals would not find themselves in a situation parallel to the Stanford experiment.

Medical Students and their "temporary wives"

This discussion is based upon an old TV documentary about medical students who were mainly male at that time. The documentary discussed how it was common for a medical student to marry while in school with no intention that the marriage would be permanent. Since medical school is tough and it is time consuming to have to run around looking for sex, the [male] medical student would just marry "someone" who would then provide him with sex and also function as sort of a live in maid to keep things tidy and clean. The girl, of course, had dreams of her great future as the wife of a guaranteed successful millionaire doctor. However, as soon as the student graduated, he would immediately divorce the "temporary wife" who had now served her purpose and could be discarded. Since the new doctor had no money and was likely in debt, the girl would get nothing in the divorce settlement. She would be simply kicked out on the street as trash. The young doctor would then be free to choose a "permanent" wife. Now, he was in a position to afford an upscale "high maintenance" girl who had social status and was well connected with the "upper class" to which he was now a member.

This description of the basic personality traits of a US doctor is very disturbing but it should not come as a surprise to anyone. Everyone knows that, if you go to a doctor in the US, the first question is definitely not, "How can I help you?", but rather, "How are you going to pay me?" If the answer is unsatisfactory, you get booted out the door. You can die on the front steps for all he cares. And, if you think this is some kind of trumped up exaggeration, go see Michael Moore's documentary "Sicko"!

DOPAMINE

Most of the drugs psychiatrists force on people are designed to block dopamine receptors in the brain. There are five known dopamine receptors and scientists keep suggesting that there are "undiscovered" dopamine receptors and would like to find them so they can make new drugs to screw them up also. The known dopamine receptors are called, simply, D1, D2, D3, D4 and D5. To get a basic understanding of dopamine receptors and the drugs that affect them, check out http://en.wikipedia.org/wiki/ Dopamine_receptor.

Parkinson's disease is caused by dopamine deficiency. So, when psychiatrists force drugs on people they tremble and shake just like people who have legitimate parkinson's disease. It is cute that one of the main "psy ops" of psychiatrists is promoting the myth that they are "correcting chemical imbalances in the brain". Parkinson's disease is caused by a real chemical imbalance in the brain and so, if anything, psychiatrists are *causing a chemical imbalance* and not curing one. Dopamine, a neurotransmitter, is essential to the internal communications network of the brain. Blocking it disrupts this communication system to various degrees depending upon the drugs used and the amount of drugs used. Drugs such as prolixin can and do kill people by shutting down the brain to the point that the person dies. These drugs are merely "chemical replacements" for the more direct methods that psychiatrists used before they had drugs such as sticking ice picks in people's heads and doing psycho surgeries. These original techniques are mostly outlawed today. When they were in common use, as is portrayed in the motion picture "Frances", it was obvious that the brain was being damaged. Today, with more subtle techniques, it is less obvious but really nothing has changed.

The drugs in the "major tranquilizer" class are more properly described as "brain disrupters". The only reason a drugged person may appear "tranquil" is that the poor soul has been brain damaged to the point that he can't think of anything to say or do so he just "sits quietly and trembles from side effects". Psycho surgeries - when allowed - had pretty much the same effect (minus the trembling from drug induced Parkinson's disease).

Playing with dopamine receptors can have a variety of weird effects. Haldol, when first marketed, was advertised to have a "subtle reorganizing effect on thought patterns". Almost sounds like brainwashing, doesn't it. But, surely, we can't have that in a "free" country. Here is a cute article about a little animal that normally mates for life. Scientists found that, after disrupting the poor creature's brain with dopamine blockers, it lost all affection for its mate: http://www.newscientist.com/article/dn8412.html

While we are on the subject of the psych drugs, it is appropriate to note a persistent "problem" in the information given out about these drugs. The FDA must approve - word for word - the official "prescribing information" or fact sheet that is included with every container of a drug and reprinted in books such as the PDR. It just seems strange that you continue to see - in the case of the psych drugs - statements that the way the drug works is "not understood". Consider, for example, Haldol. If we look at prescribing information we find, "The precise mechanism of action has not been clearly established" [http://www.rxlist.com/cgi/generic/haloper_cp.htm]. But, if we look on a technical web site designed to be used only by research scientists, we find http://www.sigmaaldrich.com/sigma/datasheet/h1512dat.pdf that Haldol is a "D2, D3 and D4 dopamine receptor antagonist (blocker)". So, the question is, why are drug companies allowed to be vague and misleading when they write prescribing information for psych drugs when they know exactly how they work and what they do?

Now, to continue on to a pretty disgusting topic from Wikipedia, the free encyclopedia, "Medical Torture" [http://en.wikipedia.org/wiki/Medical_torture] First, you just have to wonder why we even

have the phrase "medical torture" in our language. What has this society degenerated into? This article describes how the same drugs psychiatrists force on people are also forced on people during "medical torture". So what is the difference between forced drugging by a psychiatrist and "medical torture"? Apparently none: it is just a case of your choice of words. Incidentally, R015-4513 is an anxiety producing agent.

Recently there has been a propaganda program to "soften up the general public" in the United States to accept the idea that torture should be made legal. The United States already uses torture on people held at its secret prisons in foreign countries where torture is legal. "Experts" keep popping up on TV arguing how "great" torture is and how much easier it is to get information or confessions out of people if you could only torture them [using methods designed by psychologists and psychiatrists, incidentally]. Clearly, they want torture made legal in America. People should really see this as a "heads up" unless they want to live in a total police state for some weird reason.

SPIRITUAL CRIMES

Actions which interfere with a person's positive Spiritual evolution are Spiritual crimes. They represent the highest level of crime that it is possible to commit because they are acts which directly interfere with the intent of the Creator and the purpose of HIS creation. In this world, they generally go unrecognized because we live in a world based upon scientific atheism and materialism where most people are totally unaware of the true purpose of human life. Nevertheless, the crimes are recorded and must eventually be accounted for. Essentially everything done to people by psychiatrists is a Spiritual crime. We have no laws against Spiritual crimes as such but we do have laws guaranteeing freedom of religion and prohibiting interference in religion or discrimination based upon religion. A primary function of the Church of Schizophrenia is to make sure that the laws that we do have are fully understood and enforced with respect to religious freedoms and religious rights.

In certain circumstances, such as being confined in a prison, a citizen may lose some basic civil rights. However, religious rights can never be denied under any condition. By example, the Jewish religion requires all members to come together on specified "high holy days". The federal government must and does, at taxpayer expense, transport Jewish inmates of federal prisons to some central location on the "high holy days" so that they can all be together as required by their religious doctrine. Therefore, the precedent is established that the government must obey religious doctrine and can never interfere with it even if someone is convicted and in prison. There is no reason to believe that psychiatrists should somehow be exempt when the federal prison system is not. We need to impress on the general public that religious rights are absolute rights which can never be denied regardless of any set of circumstances.

Black Arts and the US Government

The practice of black arts is a Spiritual crime by definition. In the beginning of the US Government's secret program to develop black arts - which was later to become public knowledge as the "remote

viewer" program - the government went out and hired "natural" psychics off the street. There is an old "NOVA" documentary about this if you can find it. However, when the government told the psychics to use their abilities to harm or even kill people, they refused because they respected the universal laws and Spiritual laws. The lady interviewed on "NOVA" stated, "I will not do dirty work". Then, the government decided to embark on a crash program to create and train their own psychics using military people who were already conditioned to kill when commanded. Because the government operates in secret and routinely kills anyone who learns too much, no one has or likely ever will accuse it of committing Spiritual crimes as its "remote viewer" program continues to evolve.

Nomenclature of Spiritual Crimes

There are no laws covering Spiritual crimes as such. However, we do have laws which prohibit any interference by the government in the area of religion. Since all Spiritual crimes interfere or prevent one from freely practicing religion, they are covered by the US Constitution as violations of basic human rights and are therefore illegal.

1. Crimes involving damage to the libido

The libido is necessary for Spiritual practices to be successful, therefore any interference with a person's libido is a Spiritual crime. Essentially all psychiatric drugs negatively affect the libido.

2. Crimes involving damage to the Aura and/or Astral Body

A healthy Aura and Astral body are necessary for success in Spiritual practices. Damage to the Aura or to the Astral body is a Spiritual crime. Most psychiatric drugs damage the Aura by, essentially, "punching holes in it". This can be seen by anyone with Astral vision and also photographed by various methods to provide "hard evidence".

3. Crimes associated with interference to the Kundalini

The Kundalini [http://www.crystalinks.com/kundalini.html] is a powerful force dormant in most people which can be "awakened" by special practices. It gives one supernatural powers. If your Kundalini is active and you are detected by a psychiatrist you are likely to be tortured with drugs to destroy any special abilities you may have. Awakening the Kundalini is a Spiritual event and so interfering with this event is a Spiritual crime.

4. Crimes involving damage to the chakra system

The chakra system [http://www.crystalinks.com/chakras.html] is a series of energy centers in the subtle [i.e., invisible on the physical plane] body that need to be in balance to facilitate Spiritual evolution. Most psychiatric drugs interfere with the proper operation of one or more chakras. This is a Spiritual crime.

5. Crimes involving damage to physical organs known to be associated with Spiritual evolution

Certain physical organs are known to be associated with Spiritual attributes that we all have. The pituitary gland and the pineal gland, for example, are associated with the so called "third eye". The right to use the third eye is a Spiritual right. The use of psychiatric drugs which effect either the pituitary or pineal gland interfere with this right and therefore constitute Spiritual crimes.

6. Forced sterilization

Most people under the control of psychiatrists have been sterilized by the drugs which have been forced on them. In some cases, this can be reversed by stopping the drug. In other cases, the damage is permanent. For example, the drug thioridazine, originally marketed as Mellaril, when given to young girls will prevent them from ever having their first period. In many cases, they will never have a period even if they stop taking the drug later in life. This may help you understand why the government wants forced psychiatric screenings of young kids. They want to sterilize those they feel are "defective", just like Hitler did. Sterilization is a spiritual crime because in interferes with the Creator's intent to provide bodies so that Souls can continue their Spiritual development.

7. Murder of patients by psychiatrists

Murder [i.e., unjustifiable: murder by psychiatrists is done due to incompetence or deliberately as a "convenience"] is a Spiritual crime because it interferes with the sequences of events which would have occurred in the persons life if he was not murdered. It has delayed the Spiritual evolution and is, therefore, a Spiritual crime. It will likely cause the effected person to have to return in a new body to complete the sequences of experiences interrupted by being murdered.

8. Psychic rendition

Psychic rendition is the Spiritual crime of using some method to artificially direct the path of a Soul, departing a physical body, to some fate other than its natural fate. Psychic rendition can be done essentially in plain sight because no ordinary person would know what was happening. When Robert Monroe helped the government do psychic research, it was found that a spirit, i.e., an Astral body, could be effectively captured using a charged Faraday cage. This is basically any area surrounded by wire mesh which has a high voltage charge placed upon it. The research determined that, although a spirit could easily pass thru the wire, the actual electricity in the wire, which was invisible in the physical dimension, was solid in the Astral dimension and so made a "spirit cage". A practical example detected at one hospital was two rooms which were both inside a Faraday cage. One room was a hospice room where people were expected to die. The other room was a waiting room for pregnant women. The effect of this was to "catch" the souls of the people dying in the hospice room and try to force them into the new bodies of the pregnant women, thus denying them the opportunity to go to the Astral plane and, perhaps, to evolve and leave the physical plane all together. They were forced into another physical

lifetime against their will. Activities in this category represent the highest level of Spiritual crimes.

Penalties for Spiritual Crimes

Spiritual crimes are direct attacks against the Creator and the purpose of HIS Creation. They represent the highest level of crime that it is possible to commit.

Spiritual crimes are not generally recognized as such on earth because the population has spiritually degenerated into scientific atheism and materialism. However, the crime(s) are recorded and must be accounted for when you leave this plane of existence. Psychiatrists commit Spiritual crimes constantly, every day of their career. Many are atheists and just follow what they were taught in school with no real knowledge of what they are actually doing to people's lives. However some psychiatrists are aware of Spiritual matters. They take pleasure in destroying the Spiritual life of another person just like some serial murderer or rapist takes pleasure in his crimes. Penalties are harsher for this class of psychiatrist and he may receive the most severe penalty allowed in this Creation.

The maximum penalty in this Creation is the exclusion penalty. The offender is taken - as a naked Soul - to the great void and left there. This is a vast region between worlds - actually between the created worlds and the Spiritual worlds - where nothing exists. The penalty is not eternal but it will be for at least one great cycle which is the time from one "grand dissolution" to the next grand dissolution. The amount of time is unimaginable in earth years.

SUCCESSFUL MODELS

Perhaps the best successful model for the Church of Schizophrenia is the NAACP model.. There are many parallels with this model. The NAACP had to deal with a group of people whose rights had been trampled upon by society for years, just as the Spiritual rights of the schizophrenic class has. The bulk of the members of the NAACP are not independently wealthy so a successful program of litigation was used to provide an operating budget for the organization. The NAACP actively helps its members and provides them access to experts to help them achieve a better life.

These methods parallel the goals and objectives of the Church of Schizophrenia. The NAACP is legally empowered by civil rights legislation. The Church of Schizophrenia is directly legally empowered by the US Constitution.

On the other hand, nothing really empowers psychiatrists to roam the streets brain damaging people at will. They really have no legally firm right to exist at all as compared against the absolute constitutionally guaranteed right of the Church to be completely free of any government interference in the pursuit of its religious goals.

LEGAL INITIATIVES

Legal initiatives involve determining and implementing methods by which a psychiatrist can be held accountable for his actions. Additionally we need to research how to hold the drug companies which invent the brain damaging drugs that psychiatrists force on people can be held accountable for their product. We all see lawyers immediately pop up on the TV whenever a drug given to "regular people" is shown to cause harm but we never see anyone complain about psychiatric drugs which are deliberately designed to cause harm and which kill many people and leave others with permanent damage. This needs to be rectified.

Consequential Damages

Psychiatrists need to be held legally accountable for the consequential damages caused by their actions. A good example would be vision changes which is a common side effect of drugs forced on people. If you use prescription glasses and then are forced drugged by a psychiatrist it is not uncommon that you will need new glasses. Prescription glasses are not cheap. Since the psychiatrist is the cause, the psychiatrist should pay the bill for new glasses.

Accountability for murder and attempted murder

Whenever someone dies who is under attack by a psychiatrist, the psychiatrist should be investigated on suspicion of murder. Specifically, any doctor who uses IV Haloperidol on someone should be arrested and charged with capital murder if the person dies and attempted capital or first degree murder if the person lives. This is because this use of Haldol is not authorized and a government web site specifically warns doctors not to do this and that it can be fatal thus validating that this is a premeditated act of murder or attempted murder: http://www.fda.gov/CDER/Drug/InfoSheets/HCP/haloperidol.htm

DEFENSE METHODS

Justifiable Homicide

Justifiable Homicide [http://www.lectlaw.com/def/j059.htm] is authorized in any case where you feel that your life is in danger or you feel that you will suffer severe injury if you do not use lethal force to stop the attacker. Since most psychiatric drugs must carry a warning to the effect that "unexpected and unexplained deaths are possible" when this drug is used, the drug qualifies as a potentially lethal weapon. Therefore, if you are attacked by anyone armed with such a drug who you have reason to believe intends to force it on you, it would appear from the definition that use of lethal force is justified.

<u>Legal Interventions</u>

Many states have some kind of "public defender" program for people locked away by psychiatrists. However, the lawyers and doctors are generally "both on the same team" from the standpoint that they are most likely atheists and totally unaware of anything Spiritual. So, they may be of little practical use.

The Church of Schizophrenia will use some of its operating budget to provide attorneys for its members who have a basic Spiritual education and who will aggressively engage psychiatrists.

Avoidance and Noncooperation Methods

One of the easiest ways to avoid attack by psychiatrists is to simply stay out of their way. Don't talk to them. Don't talk to anyone who does talk to them. If captured, don't cooperate. This means things like (1) don't sign anything, (2) don't give them any kind of release for medical records or any other records, (3) don't allow them to take control of your social security or SSI check by making themselves a "representative payee" - if they are already pulling this stunt, you can go to any social security office and have it stopped (4) don't answer questions - you have the right to remain silent, (5) never allow yourself to think that the doctor or any other staff member is your friend and is trying to help you. They are not. Any information they get from you will be used to hurt you further. The less they know, the better off you are.

Be aware of and do not associate with anyone who is a representative of the group called "NAMI" - the National Alliance For The Mentally III. This group is a cult, mainly composed of dominating parents, who want their kids drugged into zombies so they can keep them at home as some kind of "house pet" (or maybe "house plant"). The drug companies give money to this group because it advocates forced drugging. Stay away from them, their members and anyone else who is remotely sympathetic to them. These people are bad news.

Accountability and Damage Liability for the Spiritual Crimes Committed Against Church Members

Psychiatrists, those who help them, the State governments and the Federal government are guilty of systematically persecuting Spiritual people, discriminating against them and denying them their Constitutional rights. They must be brought to justice and they must pay the affected people for the damage they have caused to them.

ACTIVE METHODS

ACTIVE MEASURES refer to methods that can be used by individuals or groups to negatively impact the cult of psychiatrists. Examples of active measures are:

1. Expose the true nature of activities inside state hospitals by smuggling in a camera phone and recording things that the hospital does not want the public to know. Even if the device is discovered, the evidence will already have been transmitted to a remote location where it can be put on the internet for

the world to see.

- 2. Investigate doctor's personal lives. Many of them are pretty weird. Publish results on the internet.
- 3. Try to recruit a "mole" someone who works at the hospital to copy confidential records and publish them on the internet.
- 4. Sue the hospital to obtain damaging evidence which can then be posted on the internet.
- 5. Publish first hand reports from patients on the internet.

ESCAPE METHODS

Once the cult of psychiatrists has identified you as someone who "needs their help" they will never voluntarily let you go. They will follow you around and harass you for the rest of your life. Unless you can find some way to break away from them and escape, they will eventually kill you. Therefore, if you want to live, escape is your only option. If you decide on escape, there are some things you need to consider:

- 1. The people in your life who believe there is "something wrong with you" you will never be able to see any of these people again because they might denounce you to the state.
- 2. You can't have a cell phone because it can be used to track and locate you.
- 3. The only safe way to communicate would be to use the mail and have a friend mail the letter from some other state you can never give away your location.
- 4. In your new location, you should realize that the new people you meet are going to treat you like anyone else. Unless you are stupid enough to tell them your past, they are not going to figure it out. So don't. The attitudes of the people you left behind only exist in the "Alice in Wonderland" world that they created and in which they believe. Once you leave your old world behind, these attitudes and beliefs no longer have any hold on you. You are free.
- 5. There are interstate agreements which may allow psychiatrists to hunt you down. Some states have less or no agreements as compared to others. In rare cases, you may need to leave the country to find someplace where you can spend the remainder of your days without fear of being attacked by a psychiatrist.
- 6. Some groups have advertised that they will help escapees find a secret underground network of sympathetic people who will help you escape and who know which states are safe to escape to and which are not.
- 7. Consider checking out pagan groups. An easy way to find one is to find the nearest Unitarian church and ask them where the nearest "CUUPS" group is located or use this link: http://www.cuups.org/content2/chapters/chapterlist.php. The Unitarian church is extremely open minded to essentially all "alternative lifestyles". The "CUUPS" wing of the church is the pagan wing. You could find some lasting friendships there. Also, these people would be able to guide you to a nearby coven if you chose. Witch's covens are secret groups so there is no chance that your participation would ever be discovered. Witches have been persecuted for basically the same reasons that caused you to be attacked by a psychiatrist, specifically, that they believe that it is their duty and right to develop all of their powers as a human being which includes "supernatural" powers like Astral travel and magic the same things psychiatrists call schizophrenic. Should you find such a group, the remainder of your life should prove

happy and fulfilling.

8. Remember that, as long as your personality type is on the list of types society wants eliminated, you will have to live a secret life just like the gay people had to when they were officially classified as "sexual psychopaths" and actively hunted down. Perhaps, in the future, your personality type will also be removed from society's "hate list" and you will be free also. However, this day has not yet come for you.

ESCAPE FROM NON TRADITIONAL SITUATIONS

Nursing Homes

People locked up in nursing homes are usually given psych drugs for "convenience". Also, it is not uncommon for state hospitals to "dump" surplus mental patients in nursing homes. Although the "hospital" may have had a legal right to hold someone against his will, as a general rule a private nursing home has no such right. A nursing home is basically a government sanctioned "death camp". The only way out is in a pine box. However, the nursing home can only make money if you are "technically alive". Alive does not mean "alert". The "home", for example, would not want you asking questions like, "Do you have a registered dietitian to plan meals?" It would be much better for them if you just sat in a chair and drooled the remainder of your life away. Since everyone involved in medical related professions now know how quick and easy [and legal] it is to turn anyone into a mindless zombie using psychiatric drugs, the temptation to do this is pretty much a "no brainer".

Fortunately, in most states, you cannot be legally committed to a nursing home. You can't leave by yourself because the goons employed by the nursing home will drag you back and tie you up saying that they are "protecting you". They have no legal authority to do this. This means that, if you can get a message out to a friend to come see you and you choose to leave with them, the nursing home cannot legally stop you. If this is the law in your state and the nursing home attempts to hold you, it is kidnapping or false imprisonment. Your friend(s) may want to be prepared to use necessary force against any agent of the nursing home if they try to forcibly hold [false imprison] you against your free will.

Jails

In recent times, it has become popular to force psychiatric drugs on people in prison. The reason is the same as the nursing homes - convenience. All a prison needs is one psychiatrist "somewhere" who will say you "are disturbed" and they can shoot you up with anything they want. And, they do. The only "advantage" to a prison is that there is a time limit [i.e., your sentence] as to how long you will be there. When you get out, you might also want to get out of that state.

Interdiction

Interdiction is a legal process that strips you of all your constitutional rights. After interdiction, you are

no longer a "legal person". The court appoints a "guardian" to make all your decisions for you. This process was originally intended to protect old people who had legitimately lost the ability to care for themselves from exploitation. However, once psychiatrists caught on to the idea, it quickly became a "legal death trap" for anyone they chose. Generally, all it takes is a letter from a psychiatrist saying something like, "The person will not take drugs voluntarily and we need a court appointed 'guardian' to watch over the person constantly to make sure the person takes drugs."

If the judge agrees - which he generally does - you are stripped of all rights - you do not exist as a person any more. Anything you own is taken away and transferred to the "guardian". You cannot get legal help because you are no longer a person. Only the "guardian" can speak for you.

In this set of circumstances, your only real option is to get out of the United States which won't be easy with no ID and no money. If you can manage to get to some other country [Mexico would be the easiest] you can gradually do something to get money - bribe someone [easy in Mexico] to get a new identity and ID and then just keep a low profile and live out the rest of your life as quietly as possible.

Legal processes take time. You must be served with some kind of notice that you are going to be hauled into court to have a guardian appointed. At this point, you still have all your legal rights and control over anything you may own. It would be a good idea to immediately liquidate all of your assets and leave the country since it is almost a certainty that the court will rule against you. You have a much better chance of survival if you escape before the court decision rather than after it. However, you will still need to establish a new identity and you will never be able return to the United States.

RECOVERY METHODS

During the initial attack by psychiatrists, the person is usually held in a government concentration camp [state "hospital"] so that brain damaging drugs can be forced on him. During this initial phase, there is a period of confusion as the brain damage occurs. Then, the brain reaches a stable state but in a condition of "diminished capacity". In other words you have been reduced from a full human being to some kind of "smarter than average" animal so that you can be used as a slave. Once this state is reached, you will likely be released from the concentration camp and ordered to take drugs for as long as you live [which is going to be about 25 years less than you would have lived without the drugs].

What has happened during this initial phase is that the brain has tried to compensate for the poisons forced on you. The brain needs dopamine receptors to function. However, the drugs have blocked them. So the brain creates "extra" receptors so that it can limp along at reduced capacity. Now, you have an abnormal brain. So, if you stop taking the poison, the brain goes back into a state of confusion because it now has too many dopamine receptors. Doctors look for this. If they notice it, they will have you sent back to the concentration camp for forced drugging.

So, there are two ways around this problem. First, if you can manage it, never take the drugs to begin with or, at least, avoid taking them whenever you can. Then, pretend to be excited for a few days and

after that just sit quietly and look ahead with a "blank" stare. This will convince the doctors that you have been successfully brain damaged. If you can do this, you will not have to go thru drug withdrawal later.

In the second case, if you cannot avoid being forced drugged, you must go thru drug withdrawal. Because your brain has been physically changed, it could take as long as seven years to completely recover. The human body completely restores itself gradually in a seven year cycle. Psychiatrists who have rebelled against mainstream psychiatrists have written guide books on how to safely stop using these drugs. Basically, you must gradually reduce the dosage - cut the pills in half or quarters and slowly take less and less until you are free of them.

In the event you cannot do this because you are being drugged with long acting injections which you cannot avoid, your only choice is to escape and then go thru a "cold turkey" withdrawal which will be painful and very confusing. Since the drugs are prescription, once you escape you will not be able to get them so that you can do a gradual dosage reduction. And, if you try to get help from a doctor, you will likely be arrested and sent back to a concentration camp where your treatment will be more severe to punish you for attempting to escape from forced drugging. It is definitely not a good situation. However, since the alternative is a totally miserable existence followed by an early death, you really have no other choice.

If the psychiatrist has managed to permanently damage you, such as in the case of *tardive dyskinesia* [http://en.wikipedia.org/wiki/Tardive_dyskinesia], the remainder of your lifetime has been ruined. You will just have to "sit it out" until you die and then return here in a new body to continue from where you were before psychiatrists attacked you. You should not commit suicide. People choose the lifetime they are about to begin based upon their needs to have certain experiences as determined by karma. Suicide is considered breaking this agreement. Once born, people generally forget their past existence, however, the agreement is still valid. People who die thru no fault of their own have completed their agreement and have access to support services and citizenship rights on the Astral plane. However, people who refuse to complete their agreement by committing suicide do not. People who die normally are allowed into the society of the Astral world. This society has everything that you could find on earth and additional things you can't find on earth. If they need to return to earth, they can take advantage of counseling and education programs on the Astral plane to help them pick a physical life situation and time period that are best for their continued Spiritual progress. These services are not available to suicides.

CHURCH FINANCIAL STRATEGY

The financial strategy of the church is to use litigation to force society to pay for the crimes it has committed against the members of the church. Specifically:

1. Sue individual psychiatrists for the damage they have done and for violations of civil rights -

specifically constitutionally guaranteed religious freedoms. [potential damages: millions]

- 2. Sue state governments for authorizing psychiatrists to force their will on church members and violating their constitutional rights [potential damages: millions/billions]
- 3. Sue the federal government for their involvement in trampling upon the religious rights of church members [potential damages: billions/trillions]
- 4. Demand "reverse discrimination" to compensate members for previous discrimination and harassment.
- 5. Demand compensation for Spiritual damage caused to church members.

CONTINUITY OF THE CHURCH

At this point in our discussion, we assume that the previous steps we have discussed were successful so that the Church of Schizophrenia should have well over a billion dollars available to it to carry on the functions of the church. Normally, the initial duty of the church would be Spiritual education. However, in this case, Spiritual education cannot begin until members effectively stop psychiatrists from harassing them and then successfully recover from the damage inflicted upon them by psychiatrists. After these goals are achieved, legitimate work on Spiritual progress may begin.

Usually, church members support the church. However, in this case, the members cannot support the church because they have no money and have been ostracized from the general society by being labeled by psychiatrists. Therefore, the church has a duty to support its members. To do this it must force society to pay for the crimes it has committed against the members of the church by trampling upon their constitutional rights. The government must pay all the costs required to support the members of the church and provide for all their basic needs.

Education Initiative

The church can provide legal experts in medical malpractice to educate members on how to recognize cases of medical malpractice so that the psychiatrist can be quickly reported, stripped of his license, sued for everything he is worth and sent to prison.

The church can provide legal experts on social security law to educate members so that they may each receive the maximum amount of federal entitlement benefits.

Outreach Initiative

Because of the absolute constitutional authority of the church, agents of the church can insist that they be allowed to visit any mental institution and "minister" to the inmates. Once inside, they can distribute church literature to educate the inmates on the true nature of psychiatry. Any inmate who chooses to join the Church of Schizophrenia would come under the immediate protection of the church and could

not be force drugged. Also, since the Supreme Court has ruled [http://www.stanford.edu/group/
psylawseminar/O'Connor.htm] that patients cannot be held against their free will without treatment, once treatment [forced drugging] is stopped, the institution involved would not be able to hold the affected person at all and so they would have to release him immediately or face legal action by Church attorneys.

Protected Community Initiative

The population of the United States is about 300 million. Psychiatrists claim that 1% of the population is schizophrenic. So three million people are schizophrenic. This is the population of a good sized city. So, when the three million schizophrenic people join the Church of Schizophrenia, they could get some land and build their own city. The government would have to pay for this. Specifically:

- 1. The government would have to pay for the houses under the section 8 housing program.
- 2. The government would have to pay for the food under the food stamp program.
- 3. The government would have to pay for the electricity under the LIHEAP program.
- 4. The government would have to pay each member of the community a monthly check under the SSDI/SSI programs.
- 5. The government would have to pay all costs associated with the children of schizophrenic parents because psychiatrists say schizophrenia is inherited so any child would be schizophrenic by definition.
- 6. The government would have **no say at all** in how the citizens of the community run their lives because the government is prohibited from interfering in a religious group by the US Constitution.

Military Wing Initiative

Many churches have a military wing or private army to defend the church. In the US, the innocent looking "moonies" are perhaps the largest purchasers of weapons. Scientology has a large stockpile of weapons. Internationally, the Catholic church operates an international military wing known as the Knights of Malta. All members of this secret group have diplomatic immunity so they can't get into trouble no matter where they go or what they do.

Any laws which might effect a person labeled schizophrenic from obtaining weapons would have no effect on the Church of Schizophrenia. The church, as a corporation, is not a living being and therefore cannot have any illness, mental or otherwise.

Spiritual Education Initiative

The Church has a duty to make a legitimate Spiritual education available to its members. In the course of such education, the true explanations behind the vague illnesses psychiatrists claim to treat should eventually become clear.

You can easily spend your life studying Spiritual science. However, we should at least begin here.

When you actively take up Spiritual studies, you are trained to look for certain standard markers which indicate your level of progress. These markers include sounds, lights and visions - the same things that would cause a psychiatrist to call you schizophrenic. Since you have already had some experiences, certain basic markers may be familiar to you. Entrance level experiences involve flashes of light, seeing constant yellow/greenish light and hearing a very high pitched sound which is weak but will become stronger if you concentrate on it. If you reach the Astral plane you will see a pink sky (exact opposite of the blue earth sky) and hear one or both of the two classic sounds associated with that plane which are the bell and conch sound. Incidentally, churches ring bells because of the bell sound on the Astral plane which is where most people go when they die and where most garden variety churches have an area they create and maintain which they think is heaven [it is not - Heaven is at least 4 planes higher up]. If you have heard any of these sounds or seen any of these standard sights you now know what they are and where you were [interdimensionally] when you heard them. There are many created worlds and, above them, many levels of unmodified space where there is no matter or time. These upper regions are legitimate Spiritual worlds or planes. Scholars divide and name the higher Spiritual worlds differently because they blend together and do not have distinctive borders. However, essentially everyone agrees on the lower created worlds where some kind of matter and time are present. The first plane above the physical world is the Astral plane. It is a known. There is no debate among mystics that it exists. The next plane up is the Causal plane or "the plane of forces". The crystals there create and maintain all that exists below. Access to this plane gives you the power of magic [real magic]. There is no dispute that it exists. This plane has an orange sky and the tops of the power crystals look like greyish-purple pyramids. Corresponding pyramids on earth can be used for "sympathetic magic" [http://www. themystica.com/mystica/articles/s/sympathetic_magic.html]. Beyond this, most agree to two more planes, the mental and etheric plane, before the true Spiritual planes begin. Spiritual Development Initiative

The Spiritual Development Initiative involves using some of the church budget to pay specialists in psychic and Spiritual scientists to help church members resume the positive Spiritual development that was interrupted ["Girl, Interrupted" is a good motion picture about psychiatrists, incidentally] when the member was attacked by psychiatrists. Types of experts would include legitimate psychics, experts in parapsychology, Kundalini masters, Reiki masters, people trained in metaphysics and those trained in advanced Spiritual sciences. No church member is going to be exactly the same. However, all church members have had some experience beyond everyday reality. Otherwise, they would have not been labeled schizophrenic in the first place. The team of experts need to determine the level of Spiritual progress each member has achieved so that they can determine the best plan for that member which will result in continued Spiritual growth. Real experts are not cheap. The ordinary member could not afford the cost. This is the true function of the church: to help these people who have been damaged and thrown away by society resume a normal Spiritual life.
